CALL TO ORDER:

Chairman Bechtel called the meeting to order at 7:02 p.m. followed by the Pledge of Allegiance.

Scheidler Subdivision: The Planning Commission gave approval of the Scheidler Subdivision. A Motion was made by Supervisor Bruner and seconded by Supervisor Paul to approve two of the three requested waivers of SALDO: Section 404: Preliminary Plan Procedure and Section 405.1a: Plan Scale. The third requested waiver of SALDO Section 606/607: Curbs & Sidewalks will not require immediate compliance conditioned upon the placement of a Note on the Plan that should Halifax Township require curbs and/or sidewalks in the future, such will be installed in accordance with the SALDO then in effect. Vote called. Motion carries 4-0. A Motion was made by Supervisor Schreffler and seconded by Supervisor Paul to approve the Scheidler Subdivision Plan with conditional approval as set forth in Review Letter 2

dated October 25th, 2023, from HRG, Inc.: Subdivision and Land Development Comment 2 and Administrative Comments 1-3. Vote called. **Motion** carries 4-0.

ENGINEER REPORT:

HRG, Inc. Engineer Alex Greenly was present to cover his report dated November 10th, 2023, for services during October 2023. It was reported by Engineer Alex Greenly that the Camp Hebron Culvert Project is out for bid.
