- **UPDATING TERMINOLOGY:** Article 3 discussion focused on definitions.
 - <u>Flag Lot:</u> The Planning Commission would like for the Flag Lot to be 30' foot in width at minimum at driveway opening. The Flag Lot Ordinance should be on the agenda for the next Planning Commission meeting.
- PLAN PROCEDURES: Article 4 discussion focused on Plan Procedures.
 - o The Planning Commission requested that Solicitor Bruce Warshawsky provide an updated red-line version prior to the next Planning Commission meeting.
- **DESIGNED STANDARDS:** Article 5 discussion focused on Designed Standards.
 - Article 5, Section 501.5: Change to Upon Completion of Zoning Ordinance instead of Upon Implantation of Zoning Ordinance.
 - o **Article 5, Section 502.2:** Street Classification-Check with Tri-County for Street Classification. Change all minor streets to local roads.
 - Section 502.2: Private Roads-Prohibited?
 - **Section 514.A:** Prive Roads-Mobile Homes?
 - o Article 5, Section 503: Easements
 - o Article 5, Section 504: Blocks-Design Standard
 - o Article 5, Section 505: Blocks-Standard Lots should be incorporated as Flag Lots
 - o **Article 5, Section 506:** Floodplains allow you to build but Floodways typically flood sooner usually harder to build.
