# PLANNING COMMISSION RECOMMENDATION:

A report was submitted for the Planning Commission meeting that was held on Monday, July 1<sup>st</sup>, 2024. Chairman Bechtel advised that the Planning Commission continued discussing the SALDO, Sign Ordinance, Flag Lot and Anderson Phase 2 was accepted for review.

Rowe Subdivision: A Motion was made by Supervisor Bruner and seconded by Supervisor Paul to grant the three Waivers of SALDO: Section 404: Preliminary Plan Procedure, Section 405.1.a: Plan Scale, and Section 508.8.b.i.20: Upon the recommendation of the Planning Commission, Halifax Township will not require immediate compliance with Sections 606/607: Curbs/Sidewalks of SALDO, conditioned upon the placement of a Note on the Plan (which condition has been satisfied) that should Halifax Township require curbs and/or sidewalks in the future, such will be installed in accordance with the SALDO then in effect; the Note has been placed on the Plan which shall satisfy this requirement. Vote called. Motion carries 5-0. A Motion was made by Supervisor Schreffler and seconded by Supervisor Paul to give conditional approval with the following conditions/contingences to be satisfied as set forth in the attached June 7<sup>th</sup>, 2024, letter from HRG: Subdivision and Land Development Comment 2 and Administrative Comments 1-3. Vote called. Motion carries 5-0.

**RockSTARt Daycare:** A **Motion** was made by Supervisor McBurney and seconded by Supervisor Paul to release the remaining Financial Security of \$2,310.00. Vote called. **Motion** carries 5-0.

194 Kinsinger Road: Solicitor Warshawsky advised the Board of Supervisors that the Zeigler Case was transferred from the Magisterial District Judge to the Courts. Discovery was sent to Mr. and Mrs. Mark Zeigler. It was advised that Nuisance at 194 Kinsinger Road is getting worse. A Motion was made by Supervisor Schreffler and seconded by Supervisor Paul to send another Nuisance Letter to Mr. & Mrs. Mark Zeigler. Vote called. Motion carries 5-0.

# **ADMINISTRATIVE:**

<u>CD 1:</u> CD 1 is up for renewal. A **Motion** was made by Supervisor McBurney and seconded by Supervisor Pual to renew CD 1 for another six months at 5.00% APY. Vote called, **Motion** carries 5-0.

# **OLD BUSINESS:**

**Keiffer Road:** No discussion or action taken.

<u>Public Railroad Crossing/CPC</u>: Solicitor Warshawsky advised that he spoke with DCNR and was advised that a 30-day notification is required to CPC prior to subdivision/deed approval.

<u>Fort Halifax Farmhouse & Barn:</u> Supervisor McBurney advised there would be a meeting Wednesday, July 10<sup>th</sup>, 2024, with Dauphin County to discuss Fort Halifax Farmhouse & Barn.

**Doli 24" pipe:** No discussion or action taken.

<u>Building Extension:</u> A **Motion** was made by Supervisor Paul and seconded by Supervisor McBurney to approve Gene Nye's Building Extension Bid of \$13,840.00. Vote called. **Motion** carries 5-0.

**SEO Inspector:** The Board of Supervisors discussed who would be responsible for scheduling the inspections and if Halifax Township is responsible for scheduling the inspections, what does the reimbursement fee look like?

**Garam Farhat-Sycamore Tree:** No discussion or action taken.

<u>Melissa Barrick:</u> A **Motion** was made by Supervisor Bruner and seconded by Supervisor McBurney to grant Mrs. Melissa Barrick an exemption from the requested sewer line connection pursuant to her Certification from the Department of Agriculture. Vote called. **Motion** carries 5-0.

## **NEW BUSINESS:**

<u>Halifax Borough Spring Cleanup Bill Contribution:</u> The Board of Supervisors requested tallying up all the residents that show up for the Spring Cleanup. Divide up the residents by the Borough and Township to figure out what percentage of residents are from the Borough and Township.

**495 Buffalo Park Road:** Item tabled at this time.

<u>HAARA PowerPoint:</u> Frank Klinger representing Halifax Ambulance presented the financial concerns and future support ideas to Halifax Township Board of Supervisors. The Board of Supervisors agreed to pay the increased amount of \$ 3,643.00 of Workers' Compensation for the Halifax Ambulance with the condition to shop for a better rate.

Sycamore Tree Removal Process: Lance Chubb had a Sycamore Tree come down in a storm on North River Road that is protected by the Sycamore Tree Ordinance that was enacted years ago. The question was raised as to who is responsible for the removal of the Sycamore Tree. A Motion was made by Supervisor Bruner and seconded by Supervisor Schreffler for Halifax Township to hire Billows Landscaping to remove the Sycamore Tree for \$1,250.00. Vote called. Motion carries 4-1. The Nay vote was Supervisor McBurney as he disagreed that Homeowner Insurance should pay for the removal of the Sycamore Tree as it is property damage during a storm.

<u>Terry Stormwater Management Billing:</u> The Board of Supervisors requested HRG, Inc. Engineer Alex Greenly to adjust Mr. Robert Terry Stormwater Management billing to equal \$1,500.00 that was initially escrowed instead of requesting Mr. Robert Terry pay additional engineering fees that total over \$1,500.00.

<u>Halifax Drama Club Donation:</u> A Motion was made by Supervisor Paul and seconded by Supervisor McBurney to make a one-time donation to Halifax Drama Club in the amount of \$500.00 with the two tickets going to a township employee. Vote called. **Motion** carries 4-1. The Nay vote being Supervisor Schreffler.

<u>Camp Hebron Culver Replacement Payment:</u> A Motion was made by Supervisor Schreffler and seconded by Supervisor Paul to approve the payment of \$96,691.10 to Farhat Excavating, LLC instead of the Original Contract Price of \$93,705.60 of the Change Order. Vote called. **Motion** carries 5-0.
