**CALL TO ORDER:** Chairman Ford called the meeting to order at 7:02 p.m.

**BUSINESS FROM THE FLOOR: Flo Mallonee** asks that the Board look closer at the SALDO where it pertains to land development. She feels there are some gray areas that need to be clearly defined.

## **OLD BUSINESS:**

**Lenker** – Nothing to discuss.

**Recreation Plan/Fee Schedule** – Mark Reed reported on the ADHOC Committee workshop that was held which consisted of himself, Donna Rode and Flo Mallonee. The proposed plan was discussed. ## **NEW BUSINESS:**

**Ft. Halifax Park Plan-** Fred commented on the park layout. His question related to the maintenance cost and who is to pay for this. Mark commented on the railroad crossing and the dangers of this. Discussion went on regarding the proposed parking area which is currently under water. Randy stated there is no right-of-way for public access. Ken Bechtel commented on the liability regarding the private crossing. The Solicitor stated he thinks there is an easement for the crossing and that the railroad is primarily liable.
