CALL TO ORDER - Chairman Bechtel called the meeting to order at 7:10 pm. followed by the Pledge of Allegiance.

ROLL CALL - Supervisors Bechtel, Bruner, Paul, Schreffler and McBurney are present along with Solicitor Bruce Warshawsky, Engineer Erik Schroeder, Roadmaster Corey Stazewski and Secretary Wendy M. Wentzel.

RECORDING MEETING – In addition to the Secretary recording the meeting, a member of the public may be recording the meeting off and on.

PUBLIC COMMENT PERIOD – Flo Mallonee commented on agenda item Permit Fees and stated that she was not in support of raising fees associated with these permits. **Melinda Warfel** stated that she was reiterating Flo Mallonee's comments.

Motion carries 5-0. **Nightwine Subdivision** – the Planning Commission is recommending conditional approval with the following waivers: Section 404 – Preliminary Plan Procedure; Section 405.1.a.xvii – Wetlands Delineation; Section 407.0.0 – Plan Scale for Lot 1; and Section 502.3.b(3) – Pavement Widening (Along the frontage of Konick Road) conditioned upon the placement of a Note on the Plan. Sections 606 and 607 are conditioned upon the standard note on the plans. **Motion** was made by Supervisor Paul and second by Supervisor Bruner to approve the five requested waivers. Vote called. Compensation - \$49,650 annually 12 days annual pay leave and paid holidays; Use of Township truck to and from home once moved to the area; Use of Township credit card; and a \$25 monthly phone stipend.
